4. A.S. Registered Nursing

- *The course outline of record and the program outline of record will be submitted to our internal CIC in October by Matthew Wanta. If approved the program will go to the BRN in January for approval, with the goal of the first cohort starting fall 2024.*
- *Professor Tannehill called for a vote of support for the RN program. The vote was unanimously approved.*
- *The RN program will be a 2-year 4 semester program. The first cohort will be a max of 10 students. There will be a 2-credit advisory course offered during the summer prior to the fall semester, but it is not a mandatory course.*
- *Applications will most likely be accepted starting in April. The application process will consist of the RN application, and the NEX preadmission test.*
- *There will be an advanced placement option for LVN, but this is not a bridge program. LVN completers are not guaranteed a spot. If there is space available, they could move into the 3rd semester if they are eligible, but again a spot is not guaranteed. LVN can apply and start from the beginning.*
- *The projected cost is \$7000-\$8000 for the full program, this is in state tuition.*
