#### II. Business Spotlight

#### Vic Anselmo from Applied Powdercoat, Inc.

Vic Anselmo provided a brief history of Applied Powdercoat, Inc. including its long relationship with Haas Automation. Powdercoating is a highly durable and environmentally friendly metal finishing. Coats include a wide variety of colors, texture, and finishes. Vendors select the type of coat desired, metal products are sprayed and then baked to set the coat. #### **III.** Meeting Review

John Clark reviewed the progress of the last two meetings which focused on student learning outcomes (SLOs), examined county-wide job descriptions, local employability needs, and for-credit manufacturing curriculum. Preliminary information for a continuing conversation of curriculum SLOs was collected through an industry survey circulated to Guild members after the April Guild meeting. Survey results were shared with the Guild.

Clark focused discussion on the CNC Operations and Manufacturing Applications Certificate program. He presented the curriculum, course by course, to facilitate Guild discussion about the relevance of the Operations and Manufacturing Applications Certificate's SLOs to industry needs. Based on previous discussions and the industry survey, Clark proposed adjustments to the curriculum and certificate requirements. Guild members provided feedback and recommendations to make the curriculum even stronger and more relevant to local employer needs. Much of the conversation focused on the value of internships and industry engagement. Additional skill needs were discussed, leading Clark to affirm that new certificates can be established at Ventura College so long as there is high demand throughout the county. The conversation will continue in June.

The results of this conversation will lead to new curriculum that will be submitted to the state for approval and adoption in the classroom in fall, 2018.
