 - ✓ Luis Suggested Ag Law/Risk Minimization course
 - Initial goal is to have all courses work toward degree. Supplemental courses to be added (ie. Regulation and compliance course)
 - Brian Cook asked if there is HR course in another division with Ag specialty. Goal to add ag related classes in business, food safety courses.
 - ✓ Annika Forrester suggested to be added as a member of this VC board by Griff Barkley – he wants coordination between district contract ed program and VC ag program.
 - ✓ Dan added that the ag supervisor course started at VC as a pilot. Brought someone in from district to run not-forcredit/contract ed portion and she runs it now. Goal for VC is to test course to determine if enough enrollment to support it as a non-credit, then get state approval for the course that will then be free tuition for participants. Overall goal is to lead students into am official state approved/transcript earning program (credit or non-credit) that will support industry goals.

- ✓ Pilot program was successful in showing that there is demand. VC wants to offer it at lower cost and have it count for credit for completers.
- ✓ Proposed Intro to Animal Science GE course, Intro to General AG (dual enrollment with Santa Paula HS − Laurie Arnold SPUSD collaborator) Fall 1919 or Spring 2020
- ✓ Need support with plant science seeking funding and instructor expertise
 - Possibility to run at East Campus
- ✓ Brett Chandler recommended FGL as resource for expertise.
- ✓ Invited Board to speak to students share career pathway stories
 - VC students first generation college attendees, underserved populations.
 - o Brian's question: Is it helpful to have members of the produce world at visits to HS.
 - Laurie students don't have a concept of what ag careers look like. Hearing industry expert stories is very helpful.
- ✓ John Chamberlain recommended having students attend trade shows, other events. Dorothy pointed out that conferences that have been attended were because they were free.
- ✓ Before PMA Limoneira will host a sustainability conference in October for pre-attendees.
- ✓ Biggest concern for VC ag program is resources. Neglected facilities.

- ✓ Anne King college gets allocation at state (same for English student and Ag student)
- ✓ Coble together federal funding, private funding with the small general funding.
- ✓ Community colleges get 9% of Higher Ed public funding but serve 50% of public Higher Ed students in CA
- ✓ Donations to VC Foundation should be identified as specifically for Ag. Then monies go directly to Ag program without restrictions.
- ✓ Federal funds have restrictions for use.
 - o Industry collaborations
 - o Mission offer to plant 1-acre avocado orchard
- ✓ Griff Barkley requests a working budget so Board can see how they can help rather than doing piecemeal donation.
- ✓ Dorothy explained budget is in the works and will be made available.
- ✓ Needs for Adjunct Faculty funds enrollment numbers don't justify college use of funds for new faculty.
- ✓ Outreach needed to increase enrollment.
- ✓ Anne philanthropy will further the goals and sidestep some bureaucracy
- ✓ Brett Horticulture would also need course enhancement

 just working in fixed environment instead of open field.
 Nutrient, water management, plant pathology needs.
- ✓ Dorothy possible to bring back greenhouse course. Willing to get all courses approved and have them waiting in the wings.
- ✓ Brian requested email into description of VC Ag program to share.
- ✓ Laurie present to HS to raise enrollment

- ✓ John Chamberlain promotional video
- ✓ Griff what is current enrollment capacity? Can't actually fill all courses because one faculty member can't teach all courses.
- ✓ Keith reinforced request for budget and said this board can afford to support it.
- ✓ Luis recommended that board reach out to colleagues to support VC Ag program.
- ✓ Griff working professionals is low-hanging fruit to increase enrollment
- ✓ Dorothy will provide Fall schedule to board for sharing. Project-based, real world learning.
- ✓ Griff have Dorothy speak at seminars for growers
- ✓ Keith any press releases? Student intern just starting will start working on this. No Ag website yet.
- ✓ John Chamberlain put up wix site (website) free, quick. Board provide support for program to get this up and running. Link district website to it when it finally comes around.
- ✓ Dan website must stay in campus page, but a consultant can be brought in to design and get it running.
- ✓ Dorothy working on a press kit, just missing a landing site to direct interested parties.
- ✓ Griff what's the process for expanding when enrollment is up? How does board support it?
- ✓ Funding will then bring another faculty. Facilities remains a limiting factor. John Chamberlain mentioned ways to expand in east county.
- ✓ Dedicated vehicle for Ag program would be a boost.
