

# Community Health Workers and Home Health Aides Labor Market Analysis: Imperial County

October 2017

#### Summary

The following summarizes findings from the labor market analysis below for Community Health Workers and Home Health Aides:

- Between 2006 and 2016, Community Health Workers increased from 9 to 20 jobs in Imperial County, and Home Health Aides increased from 123 to 187 jobs
- Both occupations are projected to increase in Imperial County and in California from 2016 to 2021
- Employers in Imperial County will need to hire 80 workers annually for these occupations to fill new jobs and to backfill jobs due to attrition such as retirement or turnover
- Between 2016 and 2021, Home Health Aides and Community Health Workers are projected to grow 112 percent and 30 percent, respectively, in Imperial County
- When compared to San Diego County, Imperial County median wages for these occupations are higher
- Five Taxonomy of Programs (TOP) codes are associated with Community Health Workers: 126100 (Community Health Care Worker); 130900 (Gerontology); 210400 (Human Services); 210440 (Alcohol and Controlled Substances); and 210450 (Disability Services)
- Three TOP codes are associated with Home Health Aides: 123000 (Nursing); 123090 (Home Health Aide); and 130900 (Gerontology)
- The data suggests that there is a supply gap for these occupations in Imperial County.

#### Introduction

This report provides labor information for selected occupations in Imperial County, and analyzes the following occupational codes in the Standard Occupational Classification (SOC)<sup>1</sup> system:

Community Health Workers (SOC 21-1094): Assist individuals and communities to adopt healthy behaviors. Conduct outreach for medical personnel or health organizations to implement programs in the community that promote, maintain, and improve individual and community health. May provide information on available resources, provide social support and informal counseling, advocate for individuals and community health needs, and provide services such as first aid and blood pressure screening. May collect data to help identify community health needs. Sample reported job titles include:

- Community Health Worker (CHW)
- Community Health Promoter

- Community Health Outreach Worker
- Community Nutrition Educator
- Community Health Program Coordinator
- Community Health Program Representative
- Apprise Counselor

Home Health Aides (SOC 31-1011): Provide routine individualized healthcare such as changing bandages and dressing wounds, and applying topical medications to the elderly, convalescents, or persons with disabilities at the patient's home or in a care facility. Monitor or report changes in health status. May also provide personal care such as bathing, dressing and grooming of patients. Sample reported job titles include:

- Home Attendant
- Certified Home Health Aide (CHHA)
- **Nursing Assistant**
- Hospice/Home Health Aide

- Licensed Nursing Assistant (LNA)
- **Direct Care Professional**
- Residential Counselor
- In Home Caregiver

## **Occupational Demand**

#### **Projected Occupational Demand**

Between 2006 and 2016, Community Health Workers increased from 9 to 20 jobs in Imperial County, and Home Health Aides increased from 123 to 187 jobs. Both occupations are projected to increase in Imperial County and in California from 2016 to 2021 (Exhibits 1a & 1b).




Exhibit 1a: Number of Jobs by Occupation in Imperial County (2006-2021)<sup>2</sup>




Exhibit 1b: Number of Jobs by Occupation in California (2006-2021)<sup>3</sup>

Employers in Imperial County will need to hire 80 workers annually for these occupations to fill new jobs and to backfill jobs due to attrition such as retirement or turnover (Exhibit 2). Home Health Aides and Community Health Workers are projected to grow 112 percent and 30 percent, respectively, in Imperial County.

## **Earnings**

These occupations make more than the self-sufficient wage (\$9.29 per hour)<sup>5</sup> for a single adult in Imperial County (Exhibit 3a).



## **Educational Supply**

Both community colleges and other educational institutions provide training for these occupations in the San Diego-Imperial region. Exhibit 4 lists the TOP codes associated with each occupation.

## Demand vs. Supply

Exhibit 6 compares the demand of labor or annual openings (Exhibit 2) with the supply of labor from both the region's community colleges and other postsecondary institutions (Exhibit 5). In Imperial County, specifically, there is a supply gap for these occupations.

Please note that this is a basic analysis of supply and demand of labor for these occupations. This data should be used to discuss the potential gaps or oversupply of workers for these occupations; however, it should not be the only basis for determining whether or not a program should be developed. Additionally, the data does not include workers who are currently in the labor force that could fill these positions or workers that are not captured by publicly available data.

#### **Student Outcomes**

**Exhibit 9: National Educational Attainment by Occupation** 


