- Dow commented that we should reconsider deactivating the Sports Management courses as there has been a resurgence of sports in the area recently. Carr explained with planned steep budget cuts these specialty classes may not be possible but we reapproach with the new Dean. She approved the changes to the curriculum. Discussed the need for more active members.

In summary, the following members approved moving forward the curriculum: Fox, Hernandez, Dow, Mustafa (B), and Corrales. Under the charge of the advisory committee, industry advisory members unanimously approved the proposed curriculum.

Also discussed were needs for department. Discussion included advertisement and marketing needs, equipment updates for faculty, and printed materials. All agreed that enhancements and instructional support was needed given the new focus of the programs and the intended pathways program.
