

Recording Arts Technician

Inland Empire/Desert Region (Riverside-San Bernardino-Ontario Metropolitan Statistical Area)

Summary

- Employment for the recording arts occupational group is expected to increase by 11%
 between 2017 and 2022 in the Inland Empire/Desert Region. Over the five-year timeframe,
 468 total job openings will be available.
- The entry-level wage for all occupations in the recording arts occupational group is above
 the MIT Living Wage estimate of \$12.30 per hour for a single adult living in the Inland
 Empire/Desert Region.
- There appears to be a slight opportunity for program growth based on the average annual number of program completions for the selected community college programs (45 average annual community college credentials, 29 other educational institution credentials, 74 credentials total), and the annual openings for recording arts occupations in the region (94 annual job openings).

Introduction

This report details two occupations relevant to the commercial music program. This program prepares students for commercial music occupations through the instruction of business skills and services necessary for the performance of music in public venues under contract. The occupations included in the recording arts occupational group are:

- Audio and Video Equipment Technicians
- Sound Engineering Technicians

Job Opportunities

In 2017, there were more than 800 recording arts jobs in the Inland Empire/Desert Region. This occupational group is projecting to increase employment 11% by 2022. Employers in the region are projected to hire 468 more workers over the next five years to fill new jobs and backfill jobs that workers are permanently vacating (includes retirements). Appendix A, Table 1 shows the projected job growth, wages, education, training, and work experience required for each of the occupations in this group.





Over the last 12 months (July 2017 to June 2018), there were 50 advertisements (ads) for jobs in the recording arts occupational group in the Inland Empire/Desert Region. From 2010 to 2017, there was an annual average of 44 job ads per year (Exhibit 2).

The average time to fill for recording arts occupations in the Inland Empire/Desert Region is two days greater than the national average. This indicates that when compared to employers throughout the country, it only marginally more difficult for local employers to find qualified candidates to fill their open positions. Exhibit 3 shows the number of job ads posted during the last 12 months along with the regional and national average time to fill.

Earnings

The entry-level wage for each of the occupations in the recording arts occupational group is above the MIT Living Wage estimate of \$12.30 per hour for a single adult living in the Inland Empire/Desert Region. Median wages for these occupations are sufficient for an adult living in a household with one other working adult and one child (\$14.50 per hour, per adult or \$30,160 annually for each adult). Exhibit 4 displays wage information for this occupational group in the Inland Empire/Desert Region.

Exhibit 7 displays the entry-level education level education typically required to enter each occupation according to the Bureau of Labor Statistics, educational attainment for incumbent workers with "some college, no degree" and an "associate degree" according to the U.S. Census, and the minimum advertised education requirement requested by employers in online job ads.

Student Completions

Exhibit 8 shows the annual average regional community college credentials (associate degrees and certificates) conferred during the three academic years between 2014 and 2017, with the relevant TOP code as well as the program title used at each college, sourced from the Chancellor's Office Curriculum Inventory (COCI). Credentials granted from other educational institutions from 2013 to 2016 are displayed in Exhibit 9, along with the relevant CIP code. Please note, a credential is not equivalent to a single person in search of a job opening since a student may earn more than one credential, such as an associate degree in addition to a certificate. Community College student outcome information is from the CTE LaunchBoard based on the selected TOP code and region.

Appendix A: Occupation definitions, sample job titles, five-year projections, and earnings for recording arts occupations

Occupation Definitions (SOC code), Education and Training Requirement, Community College Education Attainment

Audio and Video Equipment Technicians (27-4011)

Set up, or set up and operate audio and video equipment including microphones, sound speakers, video screens, projectors, video monitors, recording equipment, connecting wires and cables, sound and mixing boards, and related electronic equipment for concerts, sports events, meetings and conventions, presentations, and news conferences. May also set up and operate associated spotlights and other custom lighting systems.

Sample job titles: Audio Technician, Audio Visual Specialist, Audio Visual Technician, Audio/Visual Manager, Broadcast Engineer, Master Control Operator (MCO), Operations Technician, Production Assistant, Stagehand, Videographer

Entry-Level Educational Requirement: Postsecondary nondegree credential

Training Requirement: Less than one-month on-the-job training

Percentage of incumbent workers with a Community College Credential or Some Postsecondary

Coursework: 46%

Sound Engineering Technicians (27-4014)

Operate machines and equipment to record, synchronize, mix, or reproduce music, voices, or sound effects in sporting arenas, theater productions, recording studios, or movie and video productions.

Sample job titles: Audio Engineer, Audio Operator, Broadcast Engineer, Broadcast Technician, Master Control Operator, Mixer, Recording Engineer, Sound Engineer, Sound Technician, Studio Engineer

Entry-Level Educational Requirement: Postsecondary nondegree credential

Training Requirement: Less than one month on-the-job training

Coursework: 46%
