

Firefighter Company Officer Occupations Labor Market Information Report Monterey Peninsula College

Prepared by the San Francisco Bay Center of Excellence for Labor Market Research March 2020

Recommendation

Based on all available data, there appears to be a slight over supply of Firefighter Company Officer workers in the Bay region compared to the demand for this cluster of occupations. In the SC-Monterey sub-region (Monterey, San Benito, and Santa Cruz Counties) there is a projected annual undersupply of eight (8) students.

However, some or all of the Company Officer program at Monterey Peninsula College is focused on the "upskilling" of <u>current Firefighters</u>, so they can gain the skills needed to be promoted into the Company Officer position. Because this program serves incumbent workers, the gap analysis that shows a slight oversupply in the region and slight undersupply in the sub-region is not that relevant to this program.

This report also provides student outcomes data on employment and earnings for programs on Fire Academy – TOP 2133.50 in the state and region. It is recommended that these data be reviewed to better understand how outcomes for students taking courses on this TOP code compare to potentially similar programs at colleges in the state and region, as well as to outcomes across all CTE programs at Monterey Peninsula College and in the region.

Introduction

This report profiles Firefighter Company Officer Occupations in the 12 county Bay region and in the SC-Monterey subregion for a proposed new program at Monterey Peninsula College.

• First-Line Supervisors of Fire Fighting and Prevention Workers (SOC 33-1021): Directly supervise and coordinate activities of workers engaged in firefighting and fire prevention and control.

Entry-Level Educational Requirement: Postsecondary nondegree award

Training Requirement: Moderate-term on-the-job training

Percentage of Community College Award Holders or Some Postsecondary Coursework: 57%

Educational Supply

There are two community colleges in the Bay Region issuing 77 awards on average annually (last 3 years) on Fire Academy – TOP 2133.50. There are no colleges in the SC-Monterey Sub-Region issuing awards on average annually (last 3 years) on this TOP code.

Gap Analysis

Based on the data included in this report, there is a slight oversupply in the Bay region with 71 annual openings for the Firefighter Company Officer occupational cluster and 77 annual (3-year average) awards for an annual oversupply of 6 students. In the SC-Monterey Sub-Region, there are 8 annual openings and no annual (3-year average) awards for a slight annual undersupply of 8 students.

However, some or all of the Company Officer program at Monterey Peninsula College is focused on the "upskilling" of <u>current Firefighters</u>, so they can gain the skills needed to be promoted into the Company Officer position. Because this program serves incumbent workers, the gap analysis that shows a slight oversupply in the region and slight undersupply in the sub-region is not that relevant to this program.
