

Program Endorsement Brief:

Studio Music Instructor and Music Instructional Assistant for American River College

North/Far North Center of Excellence, March 2018

American River College is exploring creating Studio Music Instructor and Music Instructional Assistant certificates. The Studio Music Instructor certificate would provide students with a background in music education for employment as an owner or employee of a private or public music studio. The Music Instructional Assistant certificate would prepare students to teach beginning ensembles in K-12 in a paraprofessional role. The Studio Music Instructor certificate is intended as a precursor to the Music Instructional Assistant certificate. Both certificates emphasize tutoring or coaching students/clients in basic instrumental/vocal technique with an emphasis on performance pedagogy.

This report provides estimates and indicators of the labor market outlook for students exiting the proposed programs. Key findings include:

- The job market for music instructional assistants is difficult to define or analyze.
- The rate of job growth for self-enrichment education teachers is positive; however, the available data does not break out music instruction as a separate category.
- The large majority (>80%) of music instruction job postings in the study region were for music teachers, often requiring a bachelor's degree and direct teaching responsibility.
- A large percentage of self-enrichment education teachers are self-employed, comprising 42 percent of the total in 2017.
- The top employers regionally were public school districts, with most job postings in the Sacramento metro area.

Labor market data from the Bureau of Labor Statistics (BLS), U.S. Census Bureau data from EMSI and job posting data from Burning Glass are used in this report, which contains the following sections:

- Occupational demand,
- Earnings and job postings,
- Educational attainment,
- Educational supply, and
- Findings and recommendations.

Occupational Demand

There are no SOC codes that directly relate to music instructional aide. One similar option is Self-enrichment Education Teachers (25-3021). O*Net describes workers in this occupation as those who teach or instruct courses other than those that normally lead to an occupational objective or degree. Courses may include self-improvement, non-vocational and non-academic subjects. Job titles include dance instructor, driving instructor, music teacher, sports coach, swimming instructor, etc.


Exhibit 1 summarizes job trends for the SOC code in the seven-county North region, Sacramento Metropolitan Statistical Area (MSA) and California. Job counts for self-employed workers versus those employed by a traditional organization or company are compared for each region.

Exhibit 2 shows the percent change in the number of jobs between 2007 through 2017 and employment projections from 2017 through 2022. The rate of change is indexed to the total number of jobs in 2007 as the base year and compares the North region with the state.

Earnings and Job Postings

Exhibit 3 displays hourly wages for self-enrichment teachers in the North region compared to Sacramento County's living wage for a one-adult, one-child household.³ The chart highlights the differences between workers who are self-employed compared to traditional employment.

Burning Glass data on job postings provides information regarding skills, employers and job titles that relate to music instruction. A pool of 62 job postings was identified and filtered based on the North region counties and the job titles that most closely relate to music instruction. Sacramento had the largest percentage of postings, totaling 29 out of 62 postings, or 47 percent, followed by Roseville with six out 62 postings, or nearly 10 percent, and Woodland with four postings, 6.5 percent, and Mather, also 6.5 percent. Data was pulled for the 12 months from March 1, 2017 through February 28, 2018.

Exhibit 4 presents the job postings trend for music instruction jobs over the past 10 years compared to the median during the same period.




Exhibit 4: Job posting trends for music instruction in the North region⁵

Exhibit 5 shows the top job titles for music instruction occupations in the job postings. These five titles were the only ones present in Burning Glass related to the music instruction occupation.



Educational Attainment

At the national level, the typical education required for self-enrichment education teachers is a bachelor's degree. Exhibit 7 breaks down the educational attainment percentages by degree type.

Educational Supply

The COE was not able to identify programs that specifically target music instruction as a program goal. A supply count of program completions could not be completed.

Findings and Recommendations

- The job market for music instruction assistants is difficult to define or analyze. There is no direct SOC code. As a result, this report's occupational analysis relied on the broader self-enrichment education teacher category that counts jobs in unrelated areas of expertise (i.e., athletic coaching, art instruction).
- The rate of job growth for self-enrichment education teachers is positive; however, the available data
 does not break out music instruction as its own category. Due to this limitation, the expected demand for
 music instruction is unknown.
- The large majority (>80%) of music instruction job postings in the study region were for music teachers. A
 review of these postings found that nearly all required a bachelor's degree and were for a primary
 instructor, not assistant. Broader salary and education estimates based on Burning Glass data were
 inconclusive since less than one-third of the total job postings contained this information.
- A large percentage of workers in self-enrichment education teaching jobs are self-employed, 42 percent of the total as of 2017. This percentage is far greater than the percentage of self-employed persons in the overall North region economy, which was 8 percent in 2017.
- The top employers regionally were public school districts. The majority of jobs as well as current job
 postings are in the Sacramento MSA. Fewer than 10 percent of jobs fell outside the metro area, but were
 within the North region. Nearly half of all current postings were for positions in the City of Sacramento.
