

Program Endorsement Brief: 1201.00/Health Occupations, General Integrative Health and Wellness Studies (Associate of Science Degree)

The Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide Los Angeles/Orange County regional labor market supply and demand data for four occupations related to integrative health and wellness. To illuminate which occupations are immediately accessible to community college graduates, these integrative health and wellness occupations have been divided into middle-skill and above middle-skill occupations. Middle-skill occupations typically accommodate community college graduates, while above middle-skill occupations typically require a four-year degree and/or prior work experience. The occupations included in the middle-skill human resources occupation group are: social and human services assistants (21-1093), and community health workers (21-1094). The occupations in the above middle-skill human resources group are: mental health counselors (21-1014) and health education specialists (21-1091). This report is intended to help determine whether there is **middle-skill occupational demand** in the local labor market that is not being met by the supply from community college programs that align with the relevant occupations.

Based on the available data, there appears to be a supply gap for these middle-skill occupations related to integrative health and wellness in the region. While the middle-skill occupation with the majority of regional annual job openings (social and human services assistants) counts nearly one-third of its current workforce as having completed some college or an associate degree, all of the annual openings for these middle-skill occupations have entry-level wages below the living wage in Orange County. Therefore, due to some of the criteria being met, the COE endorses this proposed program. Detailed reasons include:

Demand:

- Supply Gap Criteria Over the next five years, there is projected to be 3,595 middle-skill jobs related to integrative health and wellness available annually in the region due to new job growth and replacements, which is more than the 2,423 awards conferred annually by educational institutions in the region.
 - Social and human service assistants (21-1093) and community health workers (21-1094) work in many different community and/or social service subindustries, including the field of integrative health and wellness. Therefore,

demand is likely overstated for occupations solely related to integrative health and wellness.

- The highest number of job postings were for outreach specialists, care coordinators, contact tracers, social services assistants, and case management coordinators.
- Living Wage Criteria Within Orange County, all of the annual job openings for these middle-skill occupations related to integrative health and wellness have entry-level wages below the county's living wage (\$17.36/hour).¹
- Educational Criteria Within the LA/OC region, all of the annual job openings for middle-skill occupations related to integrative health and wellness typically require a high school diploma.
 - While the national-level educational attainment data indicates 32.6% of social and human service assistants in the field have completed some college or an associate degree, only 24.1% of community health workers as well as 24.1% of health education specialists have completed the same level of education.

Supply:

- There are **14 community colleges** in the LA/OC region that issue awards in programs related to integrative health and wellness, conferring an average of **569 awards annually** between 2016 and 2019.
- Between 2014 and 2017, there was an average of **1**,**854** awards conferred annually in related training programs by non-community college institutions throughout the region.

Occupational Demand

Exhibit 1 shows the five-year occupational demand projections for the middle-skill group of occupations related to integrative health and wellness. In Los Angeles/Orange County, the number of jobs related to these occupations is projected to increase by 14% through 2024. There will be nearly 3,600 job openings per year through 2024 due to job growth and replacements. It is important to note that social and human service assistants (21-1093) and community health workers (21-1094) work in many different community and/or social service sub-industries, including the field of integrative health and wellness. Therefore, the data in Exhibit 1 is likely overstated for middle-skill occupations solely related to integrative health and wellness.

This report includes employment projection data by Emsi which uses EDD information. Emsi's projections are modeled on recorded (historical) employment figures and incorporate several underlying assumptions, including the assumption that the economy, during the projection period, will be at approximately full employment. To the extent that a recession or labor shock, such as the economic effects of COVID-19, can cause long-term structural change, it may impact the projections. At this time, it is not possible to quantify the impact of COVID-19 on projections of industry and

occupational employment. Therefore, the projections included in this report do not take the impacts of COVID-19 into account.

Exhibit 2 shows the five-year occupational demand projections for the above middle-skill group of occupations related to integrative health and wellness. In Los Angeles/Orange County, the number of jobs related to these occupations is projected to increase by 18% through 2024. There will be more than 2,300 job openings per year through 2024 due to job growth and replacements. However, Emsi uses a single aggregate code that combines substance abuse, behavioral disorder, and mental health counselors (21-1081). Since these counseling occupations are combined within the dataset and not solely representative of mental health counselors, the demand data in Exhibit 2 is likely overstated.

Wages

The labor market endorsement in this report considers the entry-level hourly wages for all of the occupations related to integrative health and wellness in this report (middle-skill and above middle-skill) in Orange County as they relate to the county's living wage. Los Angeles County wages are included below in order to provide a complete analysis of the LA/OC region. Detailed wage information, by county, is included in Appendix A.

Orange County— The majority (95%) of annual openings for all the occupations related to integrative health and wellness have typical entry-level wages below the California Family Needs Calculator hourly wage (living wage) for one adult (\$17.36 in Orange County). For the middle-skill occupation group, typical entry-level hourly wages are in a range between \$15.57 and \$16.48, which are both below the county's living wage. For the above middle-skill occupations, typical entry-level hourly wages are in a range between \$16.79 and \$20.91. Experienced workers in all four occupations can expect to earn wages between \$18.62 and \$27.31, which are higher than the living wage estimate. Orange County's average wages are below the average statewide wage of \$23.96 for these occupations.

Los Angeles County—All of the annual openings for all the occupations related to integrative health and wellness have entry-level wages above the living wage for one adult (\$15.04 in Los Angeles County). For the middle-skill occupation group, typical entry-level hourly wages are in a range between \$16.24 and \$17.24. For the above middle-skill occupations, typical entry-level hourly wages are in a range between \$17.50 and \$21.95. Experienced workers in all four occupations can expect to earn wages between \$23.80 and \$40.66, which are higher than the living wage estimate. Los Angeles County's average wages are below the average statewide wage of \$23.96 for these occupations.

Job Postings

There were 1,489 online job postings for middle-skill occupations related to integrative health and wellness students listed in the past 12 months. The highest number of job postings were for outreach specialists, care coordinators, contact tracers, social services assistants, and case management coordinators. The top skills were: case management, customer service, social services, mental health, and data entry. The top three employers, by number of job postings, in the region were: Volunteers of America, Anthem Blue Cross, and Mental Health America of Los Angeles.

It is important to note that the job postings data included in this section reflects online job postings listed in the past 12 months and does not yet demonstrate the impact of COVID-19. While employers have generally posted fewer online job postings since the beginning of the pandemic, the long-term effects are currently unknown.

Educational Attainment—The Bureau of Labor Statistics (BLS) lists the following typical entrylevel education for these occupations related to integrative health and wellness:

- **Bachelor's degree**: substance abuse, behavior disorder, and mental health counselors (21-1018) and health education specialists (21-1091)
- **High school diploma or equivalent:** social and human service assistants (21-1093) and community health workers (21-1094)

In the LA/OC region, all of the annual job openings for middle-skill occupations related to integrative health and wellness typically require a high school diploma or equivalent. While the national-level educational attainment data indicates 32.6% of social and human service assistants in the field have completed some college or an associate degree, only 24.1% of community health workers as well as 24.1% of health education specialists have completed the same level of education. Of the 74% of middle-skill integrative health and wellness job postings listing a minimum education requirement in Los Angeles/Orange County, 51% (563) requested a high school diploma, 41% (446) requested a bachelor's degree, and 8% (89) requested an associate degree.

Educational Supply

Community College Supply—Exhibit 3 shows the three-year average number of awards conferred by community colleges in the related TOP codes: Health Education (0837.00), Health Occupations, General (1201.00), Community Health Care Worker (1261.00), Gerontology (1309.00), and Human Services (2104.00). The colleges with the most completions in the region

are: Saddleback, East LA, and LA Mission. Over the past 12 months, there were four other related program recommendation requests from regional community colleges.

Non-Community College Supply—For a comprehensive regional supply analysis, it is also important to consider the supply from other institutions in the region that provide training for occupations related to integrative health and wellness. Exhibit 4 shows the annual and three-year average number of awards conferred by these institutions in the related Classification of Instructional Programs (CIP) Code: Gerontology (30.1101), Human Services, General (44.0000), and Health Services/Allied Health/Health Sciences, General (51.0000). Due to different data collection periods, the most recent three-year period of available data is from 2014 to 2017. Between 2014 and 2017, four-year colleges in the region conferred an average of 1,854 awards annually in related training programs.
