

# Program Endorsement Brief: 1240.10/ Dental Assistant Orthodontist Assistant

Los Angeles/Orange County Center of Excellence, March 2021

#### **Summary Analysis**

The Los Angeles/Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide Los Angeles/Orange County regional labor market supply and demand data related to the middle-skill occupation dental assistants (31-9091). Middle-skill occupations typically require some postsecondary education, but less than a bachelor's degree. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with the relevant occupation.

Based on the available data, there appears to be a supply gap for this occupation in the region. However, entry-level wages are lower than the living wage in Los Angeles County. **Due to some of the criteria being met, the COE endorses this proposed program.** Detailed reasons include:

#### Demand:

Supply Gap Criteria – Over the next five years, there is projected to be 1,965 jobs
 available annually in the region due to retirements and workers leaving the field,
 which is more than the 1,186 awards conferred annually by educational institutions
 in the region.

All occupations that require an educational requirement of some college, associate degree or apprenticeship;

All occupations that require a bachelor's degree, but also have more than one-third of their
existing labor force with an educational attainment of some college or associate degree; or

All occupations that require a high school diploma or equivalent or no formal education, but also require short- to long-term on-the-job training where multiple community colleges have existing programs.

- Living Wage Criteria: Typical entry-level hourly wages for dental assistants are \$14.93, which is lower than the California Family Needs Calculator hourly wage (living wage) for one adult in Los Angeles County (\$15.04).<sup>2</sup>
- Educational Criteria: The Bureau of Labor Statistics (BLS) lists a postsecondary nondegree award as the typical entry-level education for dental assistants.
  - Furthermore, the national-level educational attainment data indicates 56% of workers in the field have completed some college or an associate degree.

## Supply:

- There are seven community colleges in the LA/OC region that issue awards related to dental assistants, conferring an average of 133 awards annually between 2016 and 2019.
- Between 2014 and 2017, there was an average of 1,053 awards conferred annually in related training programs by non-community college institutions.

# **Occupational Demand**

Exhibit 1 shows the five-year occupational demand projections for dental assistants. In Los Angeles/Orange County, the number of jobs related to this occupation is projected to decrease by 6% through 2024. However, there will be nearly 2,000 job openings per year through 2024 due to retirements and workers leaving the field.

This report includes employment projection data by Emsi, which uses EDD information. Emsi's projections are modeled on recorded (historical) employment figures and incorporate several underlying assumptions, including the assumption that the economy, during the projection period, will be at approximately full employment. To the extent that a recession or labor shock, such as the economic effects of COVID-19, can cause long-term structural change, it may impact the projections. At this time, it is not possible to quantify the impact of COVID-19 on projections of industry and occupational employment. Therefore, the projections included in this report do not take the impacts of COVID-19 into account.

#### Wages

The labor market endorsement in this report considers the entry-level hourly wages for dental assistants in Los Angeles County as they relate to the county's living wage. Orange County wages are included below in order to provide a complete analysis of the LA/OC region. Detailed wage information, by county, is included in Appendix A.

**Los Angeles County:** The typical entry-level hourly wages for dental assistants are \$14.93, which is below the living wage for one adult (\$15.04 in Los Angeles County).<sup>4</sup> Experienced workers can expect to earn wages of \$22.58, which is higher than the living wage estimate.

**Orange County:** The typical entry-level hourly wages for dental assistants are \$15.79, which is below the living wage for one adult (\$17.36 in Orange County).<sup>5</sup> Experienced workers can expect to earn wages of \$23.88, which is higher than the living wage estimate.

#### **Job Postings**

There were 2,798 online job postings related to dental assistants listed in the past 12 months. The top skills were x-rays, dentistry, cardiopulmonary resuscitation (CPR). The top employers, by number of job postings, in the region were Smile Brands, Pacific Dental Services Incorporated, Western Dental Services.

It is important to note that the job postings data included in this section reflects online job postings listed in the past 12 months and does not yet demonstrate the impact of COVID-19. While employers have generally posted fewer online job postings since the beginning of the pandemic, the long-term effects are currently unknown.

#### **Educational Attainment**

The Bureau of Labor Statistics (BLS) lists a postsecondary nondegree award as the typical entry-level education for dental assistants. Furthermore, the national-level educational attainment data indicates 56% of workers in the field have completed some college or an associate degree. Of the 36% of dental assistant job postings listing a minimum education requirement in Los Angeles/Orange County, 99.4% (1,004) requested high school or vocational training and 0.6% (6) requested an associate degree.

# **Educational Supply**

Community College Supply—Exhibit 2 shows the annual and three-year average number of awards conferred by community colleges in the related TOP code: Dental Assistant (1240.10). The college with the most completions in the region is Orange Coast. Over the past 12 months, there were no other related program recommendation requests from regional community colleges.

**Non-Community College Supply—** For a comprehensive regional supply analysis, it is important to consider the supply from technical institutions in the region that provide training programs for dental assistants. Exhibit 3 shows the annual and three-year average number of awards conferred by these institutions in the related Classification of Instructional Programs (CIP) Code: 51.0601 – Dental Assisting/Assistant. Due to different data collection periods, the most recent three-year period of available data is from 2014 to 2017. Between 2014 and 2017, technical institutions in the region conferred an average of 1,053 awards annually in related training programs.
